Community Recognition Fund

In May the Government announced €50 million in funding for over 880 projects as part of the first ever Community Recognition Fund which is designed to support and reward communities that have welcomed families and citizens from Ukraine and other countries.

Mayo County Councils application resulted in the approval of €2,254,126 in respect of 48 projects across the county. Initiatives assisted under the scheme included recreational trails, lighting . outdoor gyms, playgrounds, astro surfaces, amenity areas, skateparks, sports clubs, playgrounds, street furniture, park areas, walks and rural transport.

Ballina based Cosmetics visionary takes top prize at National Enterprise Awards

Advanced Cosmetic Manufacturing is owned and ran by Noreen Hackett, a Cosmetic Chemist with over 10 years' experience in the industry who took the top prize of overall winner at the National Enterprise Awards in the Mansion House on 1st June.

One of Europe's only 'concept to shelves' cosmetics companies, based in Ballina, was set up by Noreen in 2018 before launching to market in 2022 achieving significant success during that time. Recognising an opportunity to enhance the Irish market offering, Advanced Cosmetics Manufacturing was established. The business now works with companies from formulation through to packaging, offering a "Made in Ireland" solution for Irish cosmetics companies. Some of Advanced Cosmetics' clients include SoSu Dripping Gold range, Pestle & Mortar, Bellamianta and Skingredients.

LEO Mayo has worked closely with Noreen over the years to develop her business and she has availed of training including a Start Your Own Business programme in 2018, participating in the Ireland's Best Young Entrepreneur Competition in 2019, mentoring, and financial supports through Priming And Business Expansion grants.

The Awards, which are an initiative of the Local Enterprise Offices to celebrate the best small businesses in Ireland, were held at the Round Room in the Mansion House in Dublin in what is their 23rd year. Simon Coveney TD, Minister for Enterprise, Trade and Employment, announced this year's winners in front of representatives from the Local Enterprise Offices, Enterprise Ireland and the Local Authorities and small businesses from across the country at the event.

CIVIL DEFENCE

Operations: President of the United States Joe Biden visited Ballina on the evening of 14th April 2023. Civil Defence deployed 30 members to support this historic event. Mayo Civil Defence received support from Galway and Offaly Civil Defence and worked alongside Order of Malta Ireland, An Garda Siochana, The HSE, Mayo Fire and Rescue and MCC to ensure all attendees had a safe and enjoyable experience.

Civil Defence has continued its Community/Event support program for 2023 and have attended 12 sport and community events in April & May - equating to approx. 550 volunteer hours.

Volunteer Equipment Management System (VEMS)

In 2021 the Department of Defence entered into a contract to develop a new online VEMS for Civil Defence. Final preparations are underway for the launch of the new VEMS system in second half of 2023.

Training: Civil Defence members continue to maintain their Minimum Training Standard. Members have attended national training with the Civil Defence Branch and the Environmental Protection Agency in preparation for a national radiation monitoring exercise in June also ensuring that members are up to date in the event of the deployment of this service. Local training continues on a weekly basis for all members.

FIRE SERVICES

Community Fire Safety Our Community Fire Safety team continued their proactive engagement and the Schools Summit at the GAA Centre of Excellence where they interacted positively with more than 2000 students who are preparing for their lives after the Leaving Cert exams.

POTUS visit Several Fire Brigade units were placed on standby duty to facilitate the visit of President Biden to locations at Knock Shrine, Mayo Roscommon Hospice, Enniscoe House and St. Muredach's Cathedral at Ballina while Senior Officers, as part of an interagency team worked to ensure the entire visit passed without incident.

ENVIRONMENTAL SERVICES

Blue Flag Beaches: Mayo has been awarded 12 Blue Flags for the following beaches: Dooega, Elly Bay, Keel, Keem, Mullahgroe, Mulranny, Ross Killala, Silver Strand Dugort, Golden Strand, Old Head, Bertra and Clare Island. The regaining of the 3 flags for Old Head, Bertra and Clare Island was the highest achieved and was highlighted at the awards ceremony. Mayo was also awarded 6 Green Coast Awards. The Mayo beaches included in the Green Coast Awards are Tranaun Beach on Inishturk Island, Termon Beach, Srah Beach, Cross Beach Belmullet, Rinroe Beach and Carrowniskey Beach Louisburgh.

Veterinary: During the month of May a Dog Licencing campaign was launched. Through radio and social media platforms dog owners were advised that the dog wardens would be checking for dog licences in the following areas in May—Cong, Shrule, Kilmaine, Hollymount and the surrounding areas.
