CoVid-19

From midnight on Wednesday 21st October, the county has moved to Level 5 under the Plan for Living with COVID-19.

As providers of essential services our offices remain open and the services we provide will continue to be delivered. In line with public health guidelines on remote working, and keeping our safety, and the safety of the public in mind, we are encouraging the public to make every effort to do their business with us online or over the phone. An appointments-based service is in operation where necessary.

Following the guidance laid out in Framework for Restrictive Measures, the following public buildings and venues will remain closed for the duration of the Level 5 restrictions.

- Mayo County Council Motor Tax Offices Services are available online
- Mayo County Council Libraries Online services are available
- Mayo County Council Museums and Art Centres
- Leisure Centres, Swimming pools and gyms are also closed to the public

We will continue to promote the public heath advice in relation to wearing of face coverings, cough etiquette, social distancing and reducing contacts in an effort to reduce the numbers of cases in the county and to combat the spread of the virus.

"Keeping Well" Campaign

An Taoiseach, Micheál Martin T.D, launched the "**Keep Well**" on October 29th. Local Authorities have been asked to lead out on this campaign which aims to support people and communities to mind their physical and mental health over the coming months.

The "Keep Well" campaign is focussed on five main themes:

- **Keeping active** keeping active and being outdoors, even during the winter, is important to help physical and mental health and wellbeing.
- Staying connected staying connected with people, addressing isolation, supporting volunteerism and initiatives that support person-to-person connection is important to our wellbeing
- **Switching off and being creative** switching off and being creative or learning something new, getting back to nature and finding ways to relax can help our general wellbeing.
- **Eating well** by nourishing our bodies and minds, we can develop a better connection between the food we eat and how we feel and positively impact our physical and mental wellbeing.
- **Minding your mood** equipping people with information on where to go if they need support. This will also be linked with the local community helpline to ensure that people can access the support they need.

The council has commenced work on this initiative and in conjunction with other state agencies and bodies will be rolling out programmes and initiatives in support of this campaign.

N26 Realignment at Cloongullane Bridge-Contract Signing



The contract for the N26 Realignment at Cloongullane Bridge was signed on 28^{th} October 2020. The successful tender BAM Civil Limited and the contract price is $\[\in \]$ 10 million.

The project comprises the construction of a new bridge over the River Moy to replace the existing stone arch bridge and the project will include sections of the road that approach Cloongullane Bridge.

The new bridge comprises a single span of 83.1m over the River Moy and no in-stream works will be required. The bridge is a steel composite beam structure with reinforced concrete abutments. The road development also includes two new culverts over tributaries of the River Moy, local road realignments and accommodation works/farm accesses.

The award of this project, which has been many years in planning, is welcomed and I would like to convey my thanks to the members and the staff of the Roads Office in Mayo County Council for progressing the project to this point. The project which is a significant improvement in the roads infrastructure of north Mayo will improve access to the region and will vastly improve the day-to-day commutes for the people of Swinford, Foxford, Ballina and surrounding areas.

CLIMATE ACTION:

Mayo County Council submitted its year one Climate Adaptation progress report to DCCE on October 30th. Work is ongoing on 75% of the 76 actions with work commencing in the coming period on the outstanding actions. The climate adaptation implementation plans for the period Sept 2020 – 2021 were also completed by each MCC section in October.

WASTE MANAGEMENT:

- An illegal dump site in Kilkelly was located & a clean up arranged, involving the removal of 39.42 tonnes of waste. "No Dumping" signs were installed as a deterrent.
- A Certificate of Authorisation Application was submitted to the E.P.A., in relation to the Claremorris Historic Landfill Site.

AWARENESS:

- October was National Reuse Month. An awareness campaign ran throughout the month, to encourage participation in online workshops available through My Waste and the Upcycle Challenge.
 - A series of special guest interviews were arranged on the Tommy Marren Show, on Midwest Radio, each Tuesday of the month, where discussion took place on the topic of Reuse. A series of Reuse month adverts also ran on Midwest and iRadio.
- On October 20th, eight digital Green School Seminars were ran by An Taisce and supported by Mayo County Council for Mayo schools on a range of environmental themes.
- An awareness campaign commenced following the adoption in October of the Waste Management Bye Laws (Segregation, Storage & Presentation of Household & Commercial Waste) 2020.

VETERINARY:

• Tender for Provision of Dog Pound:

Mayo County Council has invited tenders for Provision of Dog Pound and related services. This tender was published on eTenders.gov.ie (RFT 177418) and advertised in the local newspapers. The closing date was 4.00p.m. Wednesday 28th October 2020.

• Ex- Gratia Funding:

Since 2011 an allocation for animal welfare has been made available to animal welfare groups. This year an advertisement was placed in the local newspapers inviting applications for funding. We are in the process of making recommendations on the applications received.

CIVIL DEFENCE - SEPTEMBER/OCTOBER 2020:

TRAINING - Civil Defence has undertaken to recommence essential training which was suspended due to COVID 19 restrictions earlier in the year.

The following courses have been undertaken by our Volunteer members during this period: Cardiac First Responder – Community, Pre-Hospital Emergency Care Council - Responder Level Instructor Re Certifications, UAS (Drone) Pilot Recertification - Search & Rescue

OPERATIONS - Civil Defence as part of our response to the COVID 19 Pandemic, we have assisted members of our community in accessing hospital appointments.

Civil Defence has assisted the Irish Blood Transfusion Board with the logistics of their clinics in Ballina. We have assisted the Health Service Executive with their response to the pandemic in areas such as transport and delivery of essential equipment. Civil Defence in Mayo has undertaken over 80 individual taskings to date since March 2020 to support the fight against Covid 19.
