#### **Waste Permitting & Enforcement:**

#### Caro:

The CARO & Mayo County Council have been successful with two applications to Strand 2 of the Climate Action Fund that has recently been announced.

Project 1 in partnership with Leave No Trace, NUIG and MSLETB will develop educational workshops and toolkit to support coastal communities to best utilise beaches and dunes as a coastal protection.

Project 2 in partnership with NUIG and the DZ Communities in the region to establish a network to develop tools, training and community capacity to support.

#### **Climate Action updates:**

- Environment, Climate Change, Agriculture and Emergency Services SPC was held on Sept 22<sup>nd.</sup> It was agreed at both the SPC and Westport Belmullet MD meeting that the Mayo Dark Skies public lighting pilot in Newport proceed.
- The final Bertra Connected workshop focusing on the protection of the sand dunes was held on 15<sup>th</sup> Sept. The findings from the workshop series will be presented as part of Westival in late Oct.
- MCC were a key partner in the production of the McHale Park GAA Sustainability strategy which was launched in Sept. A corresponding Mayo GAA sustainability conference was held for all Mayo GAA clubs on Sept 22<sup>nd</sup>. The Climate Action Officer & Heritage officer gave presentations as the expert partners at the event.
- Mayo County Council participated in Irelands first SDG week and held a social media campaign to highlight how MCC is working toward the goals.

**Highlights:** MCC have been a successful applicant to phase one of the ESB networks Mini-generation scheme. Any excess electricity produced by the 29kW Solar PV installation at Rathroen Civic Amenity Site will now be sold to the grid.
