#### **Chief Executive Report**

As the members will be aware Ministers Burke, Noonan and Chambers have recently visited the county and Mayo County Council had the opportunity to demonstrate completed projects such as the WWTP facility at Killala, our housing development in Swinford and the facilities at Lough Lannagh. We were also able to outline our plans for developments such as Castlebar historic core, Castlebar Military Barracks and Moorehall. We had the opportunity to engage with Minister Burke on a number of issues which could impact on the finances of Mayo County Council in the years ahead.

#### Finances.

Mayo County Council received financial support from the Department of Housing, Local Government and Heritage for additional costs incurred, and loss of income as a result of Covid 19 for the year ended 31 December 2020. The financial outturn figures at Appendix A are prepared on the assumption that such support will be forthcoming for the current year. An amount of €2.84 million has been included in income under Division H Miscellaneous services in respect of this support.

In response to the onset of COVID 19, the Council's rates waiver scheme had been extended for the first three quarters of 2021 whereby the Council have waived nine months of the 2021 commercial rate liability for qualifying rate payers. The Council can recoup the cost of this waiver directly from the Department of Housing, Local Government and Heritage. It is estimated that c2,350 ratepayers will benefit from this Waiver scheme with €8.8million of rates waived for the three quarters of 2021

**Homelessness** - There were 6 homeless presentations in July (6 adults) & 8 presentations in August (7 adults and 1 child). Total from Jan to Aug - 60

#### **Defective Concrete Blocks Grant Scheme**

To date, 106 Stage 1 Confirmation of Eligibility Applications have been received, 74 Stage 1 Confirmation of Eligibility letters have issued, and 12 Stage 2 Grant Approval applications have been received of which 9 have been approved. 20 application assessed under the Scheme were deemed ineligible at this point. Appeals have been received in respect of 19 of theses and appeals are currently being considered with physical inspections having already been carried out. It is expected that these appeals will be completed in the coming weeks.
