CoVID-19

From midnight on Tuesday 06th October, the county has moved to Level 3 under the Plan for Living with COVID-19. Following the guidance laid out in this plan, the following public buildings and venues will close for three weeks.

- All Mayo County Council Libraries (A call and collect service will remain in place).
- All Mayo County Council Museums and Art Centres.

Swimming pools and Gyms will remain open with additional restrictions.

Our offices remain open, as do our public receptions, however, keeping our safety, and the safety of the public in mind, we are encouraging the public to make every effort to do their business with us online or over the phone.

Whilst Mayo has some of the lowest Covid-19 numbers in the country, we are at a critical juncture now with the numbers of confirmed cases increasing nationally. We must double down on our efforts to combat the spread of the virus.

Together with the HSE and An Garda Síochána, the Council has launched an appeal to the Mayo public in the fight against Covid-19. The appeal includes contributions from well-known Mayo sports personalities Andy Moran and Maeve Gallagher, along with our Cathaoirleach, Cllr Richard Finn. Housing

Rebuilding Ireland 2016-2021

- Housing Construction/Acquisition Programme 2016-2021.
- Rebuilding Ireland target for Social Housing in Mayo is 708 however County Council will endeavour to exceed this figure.

Progress on 2016-2021 programme is as follows:

• 485 units have been completed with another 264 in different stages of progress.

HAP and RAS

- 17 houses delivered under the HAP scheme.
- 6 houses delivered under the RAS scheme.

This gives a total of 2,145 households supported by RAS and HAP in Mayo. (1,342 HAP; 567 RAS (P); 236 RAS (V).

Leasing

In July and August 2020, the following were delivered:

- 2 houses under STL.
- 7 houses under RLS

This give a total of 236 households supported under the Leasing Programme in Mayo (225 STL; 10 RLS; 1 LTL).

Refugee Resettlement

174 persons accommodated to date (158 Mayo County Council and 16 persons accommodated by the Red Cross in pledged accommodation).

Homelessness

13 presentations for September. 68 presentations to date in 2020.

Architectural Services

- Ongoing development of 15 Housing projects throughout the County in conjunction with Housing Central.
- Oversight of all Architectural projects throughout the MDs.
- Ongoing developments of large public civic projects, such as the Ballina Military Barracks and Mary Robinson Centre, including the completion of Stage 2 of tender process for the interpretation and fit out of the Mary Robinson Centre.

<u>Heritage</u>

- Funding secured under the National Biodiversity Action Plan for Mayo Wetlands Survey Database.
- Application submitted to Department of Culture, Heritage and the Gaeltacht.
 Communities Monument Fund and advised applicants to Heritage Council's Community Heritage Grant Scheme.

Conservation

- Ballinrobe Library:Phase 1 Architectural conservation works completed.
- Historic Towns Initiative 2020 Ballina: Contracts were signed for six projects in the historic core of Ballina to support the adaptive re-use of vacant properties and allow for repairs to facades within the Pearse Street ACA.
- Ballysakeery Glebe House: Funding secured from the Department of Culture, Heritage and the Gaeltacht for urgent stabilisation works at Ballysakeery Glebe House.

<u>Parks</u>

- The opening of new recreational facilities in Achill Sound, and Aghagower.
- Commencement of the annual treatment of Japanese knotweed programme, which will cover over 2000 locations county wide.

- Ongoing work on co-ordinating applications for Town & Village Renewal, CLAR and Community Enhancement Programmes.
- 'Rest of County' Oweninny Community benefit Fund application process has been advertised
- €147,000 allocated to Mayo Sports Partnership under Dormant Account Funding Castlebar & Ballinrobe Sports Hubs, Ballina Urban Adventure Initiative, Disability Equipment, Volunteers Supports and Youth Leadership
- The Sports Small Grant Scheme was launched on the 28th September for participation and volunteer training initiatives. Closing date 23rd October.
- Childcare Committee continues to provide support on operating within Covid-19 guidelines: planning infection control, updating layout of buildings, developing policies and procedures and undertaking risk assessments.

Enterprise & Investment Unit

- A LEO Evaluation & Approvals Committee took place on 22nd September with 4 projects supported to a value of €103,769.
- The Mayo Food and Drink Strategy 2020-2025 was launched on 25th September as part of Mayo Ideas Week 2020. As part of this week LEO Mayo also ran an online workshop 'Customs Formalities & Trade with Third Countries' in preparation for Brexit.
- AEC: An interactive map of the individual enterprise hubs and the remote working services they provide is available on the Atlantic Economic Corridor website; https://www.atlanticeconomiccorridor.ie/hubs-map/
- Renewable Electricity Support Scheme success for a joint application to develop a Solar Farm in Lisduff, Claremorris by Mayo County Council and Claremorris & Western District Energy Co-operative.
- **BROADBAND OFFICE**: Wifi4EU Westnet are currently installing equipment in Crossmolina and Balla with the other 7 towns scheduled for installation of the free public Wi-Fi service between now and December.
- Broadband Connection Points in Killasser and Taugheen have had the final piece of technical equipment installed by Vodafone. Four more sites have installations scheduled for October.

Tourism, Recreation & Amenity

- Improvement works are underway on following capital projects Greenway (Mulranny 4km), Moore Hall, Bangor Trail, VeloRail Kiltimagh, Erris Head, Bowers Ballinrobe.
- Planning and design underway for Greenway and Trails network, Keem Bay Discovery Centre, Erris Adventure Bridge and Moore Hall Masterplan.
- Application submitted for ORIS Measure 1 Schemes (7 locations).
- Work is underway on design and production of a new Mayo Tourism Guide 2021 and new Greenway website.
