Homelessness Implementation Plan 2020 - 2022

This Plan was drafted in consultation with the members of Mayo Homeless Forum, chaired by Mayo County Council with representatives from - Department of Social Protection, Mayo Women's Support Services, HSE Mental Health Department, HSE Social Work Department, HSE Social Inclusion, An Garda Siochana, MABS, Irish Association for the Social Integration of Offenders (IASIO), St. Vincent de Paul, Mayo County Council Social Work Department and Mayo County Council Housing Representative.

Introduction

Mayo County Council's Homeless Implementation Plan specifies the measures proposed to be undertaken to address homelessness in the County. This document should be read in conjunction with the West Regional Homeless Action Plan (WRHAP) 2020 – 2022 which sets out the strategic framework to address the prevention and reduction of homelessness; provision of services and assistance to those that are homeless and the promotion of effective co-ordination by homeless services authorities and providers in the administrative areas of Galway City and Counties Galway, Mayo and Roscommon.

Themes and Actions for Mayo County Council

In line with the parent document for the Region – West Regional Homeless Action Plan 2020 - 2022, Mayo County Council's Homeless Implementation Plan is based on five main themes and actions.

- 1. Prevention: Provide, consolidate, and continue to develop early intervention practices for people at risk of homelessness.
- 2. Support the needs of rough sleepers.
- 3. Protection: Protect people experiencing homelessness through emergency accommodation provision and targeted support.
- 4. Progression: Identify and facilitate pathways to long-term housing solutions, providing the necessary support for homeless people.
- 5. Ensure appropriate governance and funding structures are in place.
